A Synopsis of Community Benefit in Fiscal Year 2009

CHRISTUS Medical Group, a part of the CHRISTUS Health system, continues our journey to excellence that began ten years ago by improving the health of the communities we serve. The CHRISTUS Medical Group works closely with the communities to ensure identified needs are incorporated in the communityowned plan as well as the CHRISTUS Health system's strategic plan.

We actively fulfill our mission of extending the healing ministry of Jesus Christ by supporting a broad array of community-based services and programs that facilitates access to care with special attention given to the health status of the low income, uninsured and underinsured populations. This report of community benefit is only a snapshot of the support and value provided to the communities we serve.

CHRISTUS Medical Group follows the Catholic Health Association (CHA) and State of Texas guidelines for reporting community benefit.

Charity Care is defined as the unpaid cost of medical services provided to the uninsured and underinsured, including Medicaid. During fiscal year 2009, CHRISTUS Health Medical Group provided more than \$4.7 million in



Charity Care, which is 32.6 percent of the region's net patient revenue. Of this amount, **Unpaid Government Indigent Care** for the underserved, predominately Medicaid, comprises more than \$4.1 million of unpaid costs for fiscal year 2009, which is 28.8 percent of net patient revenue.

CHRISTUS Health Medical Group also contributed more than \$225,626 in **Community Services** to the Medical Group community in fiscal year 2009. Thus, CHRISTUS Health Medical Group provided \$4.9 million in total community benefit, which is 34.2 percent of net patient revenue earned in fiscal year 2009. This equates to more than \$13,500 a day in community benefit. CHRISTUS Health Medical Group reinvests all profits we earn back into the community through expanded health services, new technologies and better facilities.

In addition, cost of **Unpaid Government Sponsored Programs**, mostly Medicare is reported to the state of Texas following the state's Community Benefit reporting requirements. This year, that amount for CHRISTUS Health Medical Group was more than \$5.2 million, or 36.2 percent of the region's net patient revenue. In accordance with CHA Guidelines, CHRISTUS Health Medical Group does not include this amount in reports of community benefit provided to other agencies.
